A NOTE ON OUR FINANCIAL REALITY

The Situation

Our community understands that we operate as conservatively as possible to make every dollar go further. Last year at this time, we reported a lean year and, with your help, managed to avoid a shortfall. This year, however, rising operational costs, declining public revenue, and fewer starting reserves mean we are forecasting an \$87,000 deficit by the end of 2025.

Why the Gap Is So Large?

It's been an unfortunate perfect storm of factors. Earned revenue from admissions, gift shop sales, and programs has dropped by nearly 45%, and membership renewals and donations have come in lower than we expected. At the same time, the cost of nearly everything we rely on to operate has gone up. Building maintenance expenses are up more than 35%, and insurance premiums have risen about 15%, just two examples of how rising prices are affecting every corner of our budget, from exhibit materials to basic supplies.

What's Being Done?

We have already reduced expenses where we could, mostly from cutting office, exhibit, and program costs, and also reallocating funds from other less essential areas, but expenses continue to rise faster than income. To further offset costs, we made the difficult decision not to rehire our Operations Coordinator, saving about \$10,000 through the end of the year, and held a midyear fundraiser that raised nearly \$9,000. While these steps helped, they covered only a small portion of the gap.

Looking ahead, we are planning new revenue initiatives for 2026, including expanded gift shop offerings, sponsored admission days, and updated rental packages. Your support today is essential to give these long-term plans a chance to succeed.

What This Means for NCHS?

If this deficit continues, we will be forced to make painful choices that directly affect community access to NCHS.

- **Reduced Access:** To manage rising energy and utility costs, we are considering closing an additional day each week. This means fewer opportunities for researchers to use the archives, for visitors to explore exhibits, and for students to experience field trips.
- **Slower Services and Program Reductions:** With fewer staff, exhibit updates will take longer, programs may be scaled back, and wait times for processing memberships and donations will increase.
- **Deferred Building Maintenance:** Maintenance and inspections are essential to upkeep both the Cox House and the Treaty Site History Center. Delaying necessary repairs increases long-term risks to our facilities and the collections they protect.

We are educators, preservationists, storytellers, and neighbors. Right now, Nicollet County's shared history is at risk of becoming less accessible without your help.

What You Can Do?

This community has always shown up for local history, and we need your support now more than ever to bridge the \$87,000 gap. We know that is a big ask in an uncertain economy. If you can make a year-end donation, we are deeply grateful. If not, there are still meaningful ways to help:

What should I do when I arrive?

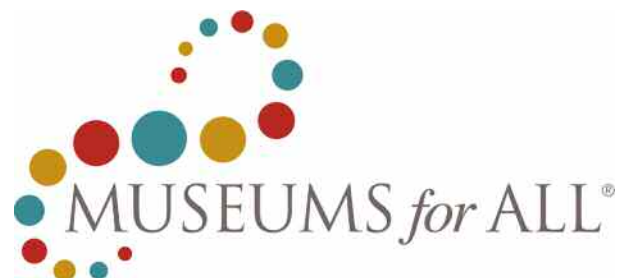
Simply show your SNAP/EBT card at the admissions desk. The card is for identification purposes only.

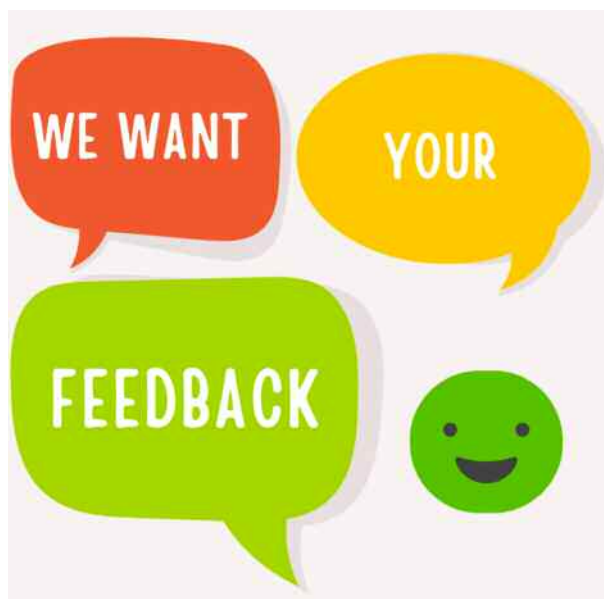

FROM THE ARCHIVES by Bob Sandeen, Research Assistant

The archives of the Nicollet County Historical Society contain an abundance of resources available to individuals with questions related to Nicollet County in some manner. Many of the questions we are asked are genealogical in nature. We can use birth, marriage, death, church, census, cemetery, land purchase, and land sale records, as well as donated family histories and a vast collection of obituaries, to find answers. We also have an extensive collection of atlases and plat books that show the properties of rural landowners and the boundaries of their properties, dating back to 1885. It is even possible that our photo collection contains some images that would be helpful. I have shown people photos of ancestors that they have never seen before, which has made quite a few people extremely happy! Our extensive book collection may also contain information about people of interest to those we are helping. Many of our books contain useful genealogical information that would be difficult to find elsewhere.

Our newspaper collection spans issues from 1855 and continues to the present day. I used the collection to find an enormous amount of information about my own family before 1924, when the farm in Oshawa Township was sold. I was surprised to read in a 1890s newspaper that my great-grandfather had purchased land in Kasota Township, Le Sueur County, along the road to Ottawa, even though his farm was located a very short distance northwest of Resurrection Cemetery on the western edge of St. Peter. I used the museum's 1898 Le Sueur County atlas to see the property location and boundaries on its map of Kasota Township.

We can provide information about businesses, railroads, bridges, ferries, schools, churches, hospitals, military units and organizations, fur traders and their trading posts, the Treaty of Traverse des Sioux, Fort Ridgely, the Dakota War, ghost towns, and many other subjects concerning Nicollet County. We also have an extensive map collection that

dates back to the 1800s. Additionally, we possess a substantial amount of information about the Civil War, World War I, and World War II, as well as their connections to Nicollet County.

The range of topics about which we are asked is impressive! Fortunately, we can provide information for a high percentage of the questions. Many people have commented that they had no idea that we have such an abundance of resources. If you have any questions for us, please come and see us!

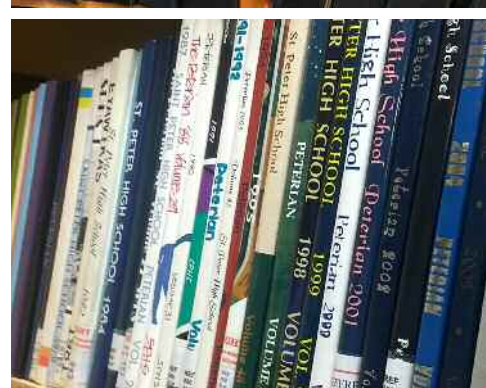

TRAVERSE DES SIOUX



Completed resurfacing project on the prairie loop trail

The Minnesota Historical Society and the Nicollet County Historical Society have worked together at Traverse des Sioux since the Treaty Site History Center was built. Visitors to the state historic site can walk a self-guided mile-long loop just north of the visitor center.

In June, the trail was resurfaced and a new trailhead was established. The main loop is now ADA compatible, increasing accessibility for visitors. The Minnesota Historical Society and Nicollet County Historical Society are grateful to the Carl and Verna Schmidt Foundation for their generous support, which made this project possible. This project was managed by David Briesse, MNHS Jeffers Petroglyphs Site Manager and St. Peter resident.

A controlled burn, conducted by trained MNHS staff, is planned for the spring of 2026. This prairie restoration will target multiple aggressive invasive species and clear the dead thatch layer to make space for native seed germination.

Interpretive trail panels at Traverse des Sioux have been removed as part of an MNHS effort to replace interpretive signage across all of our state historic sites network. Many of these signs, like the ones at Traverse des Sioux, were old, faded, or missing. This multi-year project was made possible through funding provided by the Minnesota Legacy Amendment Arts and Cultural Heritage Fund, through the vote of Minnesotans on November 4, 2008. The Legacy Amendment supports efforts to preserve Minnesota land, water, and legacy, including Minnesota history and cultural heritage. Truly a cross-institutional effort, the signage project involves staff from the Exhibits, Research, and Native American Initiatives departments, as well as historic sites staff. These stories could not be told without the close collaboration and consultation with the Minnesota Historical Society Indian Advisory Council, Tribal Partners, local historical organizations, and agencies like the Minnesota DNR.

New interpretive panels have been installed at historic sites including Lower Sioux Agency, Jeffers Petroglyphs, Birch Coulee Battlefield, and Harkin Store. New panels are under development at Fort Ridgely, with work planned for Traverse des Sioux next.

COLLECTION SPOTLIGHT by Anna Simmons, Collections Assistant

Of the thousands of articles of clothing in the museum's collection, it's surprisingly rare to see an image of the original owner actually wearing one of the garments. Every so often, however, a photograph surfaces that captures just that, giving us a glimpse of the garment as it was meant to be worn, and reminding us of its importance to the collection.

It's no surprise that wedding gowns, christening gowns, and graduation dresses are some of the more abundant examples in the collection, with wedding attire being the most often photographed. These are garments tied to milestones and are chosen with care, worn with joy, and then kept as mementos of those occasions to be treasured for years to come.

While seeing these dresses laid flat or even displayed on a mannequin can be something quite special, it doesn't give a complete picture. A photograph reveals the garment in its original splendor, showing how it fit and looked when worn, and also reminds us of its importance to the person who wore it. On the other hand, the garment itself enhances our perception of the photograph. The colors and textures of the fabrics, the architecture of its construction, and many of its intricate details can disappear into the complexity of the photo. When both the garment and its photograph survive, they tell a fuller story: one of cherished memories and moments important enough to be preserved for a lifetime.

Viewed side by side, the photograph and the garment enrich our understanding by completing the picture and providing a fuller sense of the garment's significance to the person who once wore it.
